Dear Chief Mowat,

The City of Vaughan (City) is updating the 2012 Vaughan Transportation Master Plan and creating a new Vaughan Transportation Plan (VTP). The City has retained HDR to complete this new Transportation Plan in accordance with the Municipal Engineers Association's Municipal Class Environmental Assessment process (MCEA, October 2000, as amended in 2007, 2011 and 2015), Phases I and II. The VTP is a strategic transportation City-wide study that will identify growth and intensification needs for the next 20 years. The study area covers the entire City of Vaughan as identified on the map provided as Attachment 1. The VTP was initiated in June 2019 with a formal Notice of Commencement released in November 2019 which has been provided as Attachment 2. The study is scheduled to be completed in early-to-mid 2022.

The VTP will identify potential infrastructure projects and evaluate these using multi-faceted criteria, including environmental sustainability and climate change resilience, among others, in order to determine a preferred list of projects. Potential impacts to the natural and cultural environments including archaeological will be documented through a desktop review only. This preferred list will be carried forward to future steps such as detailed environmental studies, design and construction. Further investigation of the impacts, and identification of mitigation measures, will be conducted as part of required environmental assessment and/or other municipal infrastructure approval processes that will come at a later date. Therefore, we do not anticipate any environmental or archaeological impacts at this time.

Part of the MCEA process is to receive information and feedback from members of the public, residents, stakeholders and our Indigenous Communities with an interest in Vaughan. Therefore, we have attached the Province's letter dated December 10, 2019 delegating the Duty to Consult to the City. As such, we hope to understand if your community has an interest in this project. 



Dear Mr. Tam,

This letter is in response to the Notice of Commencement for the above noted project. The Ministry of the Environment, Conservation and Parks (MECP) acknowledges that the City of Vaughan has indicated that the study is following the approved environmental planning process for a Master Plan under the Municipal Class Environmental Assessment (Class EA).

It is our understanding that the City of Vaughan plans to complete the master plan at a high level where the plan identifies the schedule B/C projects but does not complete a project-specific level of study so that the projects are subject to project-specific EA studies later. The city notes that there is potential to go to project-specific level of detail for each of the schedule B projects, so that the completion of the master plan will also be the notice of completion for schedule B projects. The City will be in a better position to determine whether this level of detail will be completed as the study progresses. The City will inform MECP if they decide to go with this option. The City will not be going into project-specific level of detail for Schedule C projects.

Given that project-specific detail may be completed for the master plan, the MECP would like to advise that an air quality impact assessment(s) may be required depending on the projects identified. Please keep us regularly updated on the study, including the projects identified and the level of study that will be completed for each project, and the MECP will provide guidance at that time related to the air assessment.

The attached "Areas of Interest" document provides guidance regarding the ministry's interests with respect to the Class EA process. Please identify the areas of interest which are applicable to the project and ensure they are addressed. Proponents who address all of the applicable areas of interest can minimize potential delays to the project schedule.

The Crown has a legal duty to consult Aboriginal communities when it has knowledge, real or constructive, of the existence or potential existence of an Aboriginal or treaty right and contemplates conduct that may adversely impact that right. Before the proponent may proceed with this project, the Crown must ensure that its duty to consult has been fulfilled, where such a duty is triggered. Although the duty to consult with Aboriginal peoples is a duty of the Crown, the Crown may delegate procedural aspects of this duty to project proponents while retaining oversight of the consultation process.

The proposed project may have the potential to affect Aboriginal or treaty rights protected under Section 35 of Canada's *Constitution Act* 1982. Where the Crown's duty to consult is triggered in relation to the proposed project, **the MECP is delegating the procedural aspects of rights-based consultation to the proponent through this letter.** The Crown intends to rely on the delegated consultation process in discharging its duty to consult and maintains the right to participate in the consultation process as it sees fit.

Based on information provided to date and the Crown's preliminary assessment the proponent is required to consult with the following communities who have been identified as potentially affected by the proposed project:

- Mississaugas of the Credit First Nation
- Alderville First Nation
- Curve Lake First Nation
- Hiawatha First Nation
- Mississaugas of Scugog Island First Nation
- Huron-Wendat Nation (if there is potential for archeological resources to be impacted)











The City of Vaughan (City) is updating the 2012 Vaughan Transportation Master Plan and creating a new Vaughan Transportation Plan (VTP). The City has retained HDR to complete this new Transportation Plan in accordance with the Municipal Engineers Association's Municipal Class Environmental Assessment process (MCEA, October 2000, as amended in 2007, 2011 and 2015), Phases I and II. The VTP is a strategic transportation City-wide study that will identify growth and intensification needs for the next 20 years. The study area covers the entire City of Vaughan as identified on the map provided as Attachment 1. The VTP was initiated in June 2019 with a formal Notice of Commencement released in November 2019 which has been provided as Attachment 2. The study is scheduled to be completed in early-to-mid 2022.

The VTP will identify potential infrastructure projects and evaluate these using multi-faceted criteria, including environmental sustainability and climate change resilience, among others, in order to determine a preferred list of projects. 



This letter is in response to the Notice of Commencement for the above noted project. The Ministry of the Environment, Conservation and Parks (MECP) acknowledges that the City of Vaughan has indicated that the study is following the approved environmental planning process for a Master Plan under the Municipal Class Environmental Assessment (Class EA).

It is our understanding that the City of Vaughan plans to complete the master plan at a high level where the plan identifies the schedule B/C projects but does not complete a project-specific level of study so that the projects are subject to project-specific EA studies later. The city notes that there is potential to go to project-specific level of detail for each of the schedule B projects, so that the completion of the master plan will also be the notice of completion for schedule B projects. The City will be in a better position to determine whether this level of detail will be completed as the study progresses. The City will inform MECP if they decide to go with this option. The City will not be going into project-specific level of detail for Schedule C projects.

Given that project-specific detail may be completed for the master plan, the MECP would like to advise that an air quality impact assessment(s) may be required depending on the projects identified. Please keep us regularly updated on the study, including the projects identified and the level of study that will be completed for each project, and the MECP will provide guidance at that time related to the air assessment.

The attached "Areas of Interest" document provides guidance regarding the ministry's interests with respect to the Class EA process. Please identify the areas of interest which are applicable to the project and ensure they are addressed. Proponents who address all of the applicable areas of interest can minimize potential delays to the project schedule.

The Crown has a legal duty to consult Aboriginal communities when it has knowledge, real or constructive, of the existence or potential existence of an Aboriginal or treaty right and contemplates conduct that may adversely impact that right. Before the proponent may proceed with this project, the Crown must ensure that its duty to consult has been fulfilled, where such a duty is triggered. Although the duty to consult with Aboriginal peoples is a duty of the Crown, the Crown may delegate procedural aspects of this duty to project proponents while retaining oversight of the consultation process.

The proposed project may have the potential to affect Aboriginal or treaty rights protected under Section 35 of Canada's *Constitution Act* 1982. Where the Crown's duty to consult is triggered in relation to the proposed project, **the MECP is delegating the procedural aspects of rights-based consultation to the proponent through this letter.** The Crown intends to rely on the delegated consultation process in discharging its duty to consult and maintains the right to participate in the consultation process as it sees fit.

Dear Chief LaRocca,

The City of Vaughan (City) is updating the 2012 Vaughan Transportation Master Plan and creating a new Vaughan Transportation Plan (VTP). The City has retained HDR to complete this new Transportation Plan in accordance with the Municipal Engineers Association's Municipal Class Environmental Assessment process (MCEA, October 2000, as amended in 2007, 2011 and 2015), Phases I and II. The VTP is a strategic transportation City-wide study that will identify growth and intensification needs for the next 20 years. The study area covers the entire City of Vaughan as identified on the map provided as Attachment 1. The VTP was initiated in June 2019 with a formal Notice of Commencement released in November 2019 which has been provided as Attachment 2. The study is scheduled to be completed in early-to-mid 2022.

The VTP will identify potential infrastructure projects and evaluate these using multi-faceted criteria, including environmental sustainability and climate change resilience, among others, in order to determine a preferred list of projects. Potential impacts to the natural and cultural environments including archaeological will be documented through a desktop review only. This preferred list will be carried forward to future steps such as detailed environmental studies, design and construction. Further investigation of the impacts, and identification of mitigation measures, will be conducted as part of required environmental assessment and/or other municipal infrastructure approval processes that will come at a later date. Therefore, we do not anticipate any environmental or archaeological impacts at this time.

Part of the MCEA process is to receive information and feedback from members of the public, residents, stakeholders and our Indigenous Communities with an interest in Vaughan. Therefore, we have attached the Province's letter dated December 10, 2019 delegating the Duty to Consult to the City. As such, we hope to understand if your community has an interest in this project. 



Dear Mr. Tam,

This letter is in response to the Notice of Commencement for the above noted project. The Ministry of the Environment, Conservation and Parks (MECP) acknowledges that the City of Vaughan has indicated that the study is following the approved environmental planning process for a Master Plan under the Municipal Class Environmental Assessment (Class EA).

It is our understanding that the City of Vaughan plans to complete the master plan at a high level where the plan identifies the schedule B/C projects but does not complete a project-specific level of study so that the projects are subject to project-specific EA studies later. The city notes that there is potential to go to project-specific level of detail for each of the schedule B projects, so that the completion of the master plan will also be the notice of completion for schedule B projects. The City will be in a better position to determine whether this level of detail will be completed as the study progresses. The City will inform MECP if they decide to go with this option. The City will not be going into project-specific level of detail for Schedule C projects.

Given that project-specific detail may be completed for the master plan, the MECP would like to advise that an air quality impact assessment(s) may be required depending on the projects identified. Please keep us regularly updated on the study, including the projects identified and the level of study that will be completed for each project, and the MECP will provide guidance at that time related to the air assessment.

The attached "Areas of Interest" document provides guidance regarding the ministry's interests with respect to the Class EA process. Please identify the areas of interest which are applicable to the project and ensure they are addressed. Proponents who address all of the applicable areas of interest can minimize potential delays to the project schedule.

The Crown has a legal duty to consult Aboriginal communities when it has knowledge, real or constructive, of the existence or potential existence of an Aboriginal or treaty right and contemplates conduct that may adversely impact that right. Before the proponent may proceed with this project, the Crown must ensure that its duty to consult has been fulfilled, where such a duty is triggered. Although the duty to consult with Aboriginal peoples is a duty of the Crown, the Crown may delegate procedural aspects of this duty to project proponents while retaining oversight of the consultation process.

The proposed project may have the potential to affect Aboriginal or treaty rights protected under Section 35 of Canada's *Constitution Act* 1982. Where the Crown's duty to consult is triggered in relation to the proposed project, **the MECP is delegating the procedural aspects of rights-based consultation to the proponent through this letter.** The Crown intends to rely on the delegated consultation process in discharging its duty to consult and maintains the right to participate in the consultation process as it sees fit.

Based on information provided to date and the Crown's preliminary assessment the proponent is required to consult with the following communities who have been identified as potentially affected by the proposed project:

- Mississaugas of the Credit First Nation
- Alderville First Nation
- Curve Lake First Nation
- Hiawatha First Nation
- Mississaugas of Scugog Island First Nation
- Huron-Wendat Nation (if there is potential for archeological resources to be impacted)

Steps that the proponent may need to take in relation to Aboriginal consultation for the proposed project are outlined in the "Code of Practice for Consultation in Ontario's Environmental Assessment Process" which can be found at the following link: <https://www.ontario.ca/document/consultation-ontarios-environmental-assessment-process>

- The proponent has reason to believe that the proposed project may adversely affect an Aboriginal or treaty right;
- Consultation has reached an impasse;
- A Part II Order request or elevation request is expected.
