Economic Impact

The projected cost of undertaking the additional tasks, as reflected in the Scope of Work described below, is \$46,372.36 which will be funded from the non-allocated portion of the existing budget in the amount of \$28,299.64, from City-Wide Development Charges (CWDC) – Management Studies in the amount of \$7,229.09, and from the 2014 Policy Planning Operating Budget – Professional Fees in the amount of \$10,843.63.

The existing budget for undertaking the Natural Heritage Network Study was included in the 2011 Capital Budget (PL-9025-11) on the basis of a two part allocation. Phase 1 was treated as a stand-alone project and was funded in the amount of \$52,400. In the 2012 Capital budget, the funding for Phases 2, 3, and 4 was approved at \$199,700. The total budget for the preparation of the Natural Heritage Network Study was \$252,100. The balance remaining from the existing Capital Project (PL-9025-11) is \$28,299.64, such that the request for additional funds is in the amount of \$18,072.72 and funded 40% or \$7,229.09 from the City-Wide Development Charges (CWDC) – Management Studies and 60% or \$10,843.63 from the 2014 Policy Planning Operating Budget – Professional Fees.

Background - Analysis and Options

NHN Study Process and Consultation To-Date

The NHN study has been undertaken in four Phases:

- Phase 2 Field investigations, with a focus on evaluation of headwater drainage features and significant wildlife habitat;
- Phase 3 Data analysis, synthesis and recommendations; and

Phase 1 of the NHN Study has been completed and a staff report summarizing the findings was provided to Committee of the Whole (Working Session) on December 4, 2012. Committee of the Whole recommended that a summary of the public consultation component be provided to the January 15, 2013 Committee of the Whole meeting; and Phase 1 was subsequently approved by Council on January 29, 2013. A comprehensive GIS database was developed and delivered to the City, recommendations to revise the Environmental Management Guideline were provided, and recommendations for field investigations assisted in identifying sample sites and in finalizing the survey protocols.

The Terms of Reference for Phases 2-4 of the NHN Study was approved by Council on September 25, 2012, and the consulting contract for the corresponding Request for Proposal (RFP) was awarded on January 29, 2013. An update following completion of the field investigations was provided to the Committee of the Whole (Working Session) on December 3, 2013.

The consulting team's draft reports were made available to the public for the June 17, 2014 Committee of the Whole (Public Hearing). The staff report summarized the findings of the Study for the purposes of obtaining public comment prior to its finalization with particular emphasis on:

- Criteria for refinement of the Core Features and Enhancement Areas of the NHN; and
- Recommended modifications to select policies of Chapter 3 (Environment) and Schedules of the VOP 2010.

Consultation has occurred throughout the process, with particular emphasis on Phases 2 to 4. This is documented in the staff report for the June 17, 2014 Committee of the Whole (Public Hearing). In addition to interactive online information updates, the following is a summary of public consultation measures:

Next Step: Technical Report Content Outline

The Technical Report will be provided to a future Committee of the Whole meeting. It will summarize the feedback received at the June 17, 2014 public hearing during the public comment period and any resulting changes that may be recommended to the:

- consulting team report on the NHN Study findings and recommendations;
- consulting team report on the Conservation Land Securement Strategy;
- Environmental Management Guideline; and
- Policies and schedules of the VOP 2010.

An outline of the content of the Technical Report is provided below, which informs the Scope of Work and budget estimate for additional funds to extend the North-South Environmental contract. The Technical Report will:

 - Review the assessments of headwater drainage features and significant wildlife habitat, particularly in relation to the final NHN scenarios and feasibility of the long-term maintenance of ecological features and functions.
- c) Revise the Environmental Management Guideline (EMG)
 - Review and incorporate comments provided in response to the draft EMG made available in June 2013; and
 - Update the EMG based on the relevant findings of the NHN Study.
- d) Provide an outline of the recommendations regarding (i) the Provincial review of the ORMCP and Greenbelt Plan; (ii) the GTA West Corridor EA, and (iii) a habitat compensation framework as a tool to implement the NHN Study findings.
 - Review the NHN scenarios, including the assessment of the potential impact of the GTA West Corridor, in relation to achieving select ecosystem targets.

Proposed Scope of Work

It is recommended that the contract with North-South Environmental Inc. be extended to support the completion of the Technical Report, following the June 17, 2014 Public Hearing, including the review of changes based on stakeholder input into the materials made available to the public. Specific tasks required to complete the Technical Report include:

- Changes to the GIS data comprising the NHN mapping based on recent approvals of development applications by the City;
- Changes to NHN mapping, revisions to Schedule 2 "Natural Heritage Network" of VOP 2010 and review of the proposed policy changes as a result of the review of the submissions and required stakeholder consultations following the meeting of the Committee of the Whole (Public Hearing) on June 17, 2014;
- Refinements to the NHN study resulting from the discussions with stakeholders.
- A thorough review of the history of modifications to Core Features and Enhancement Areas boundaries to ensure consistent application of decision rules;
- Responses to recommendations from the public for updated interactive maps of the NHN data; and
- Cataloguing GIS data to share with appropriate City partners to aid in projects related to infrastructure and/or conservation.

As a result, the additional funding request is based on the following main activities which will be supported by the consulting team:

- Edits and management of GIS data and VOP 2010 schedules;
- Consultation with stakeholders, evaluation of submissions;
- · Analysis and Reporting; and
- Following the completion of the Technical Report, efforts to refine the GIS data and/or VOP 2010 schedules and resolution of policies through the official plan approval process.

City staff have completed a review of recently approved development applications and required changes to the NHN mapping. City staff have also completed a preliminary review of all submissions in response to the materials made available for the June 17, 2014 Public Hearing. This allows for additional consultation to be scheduled over the next two months to finalize any amendments to Schedule 2 and policies of Chapter 3 of VOP 2010.

It is expected that the Technical Report will proceed to Committee of the Whole in early 2015. Subject to Council approval, the implementing amendment to the policies and schedules of VOP 2010 will go to Council for adoption; and then move to the York Region approval process. It will take approximately one year to complete these processes. It will be important to maintain the consulting services after the adoption of the Official Plan amendment in the event that post adoption modifications are required. Through this period, it will also be important to continually update the mapping data to maintain currency to the point of the final approval of the Official Plan amendment.

Implications for the Approved Budget

Funding for the Natural Heritage Network Study was included in the 2011 Capital Budget (PL-9025-11) in the amount of \$252,100 on the basis of a two part allocation. Phase 1 was treated as a stand-alone project and was funded in the amount of \$52,400. In the 2012 Capital budget, the funding for Phases 2, 3, and 4 was approved at \$199,700. The staff report to the January 29, 2013 meeting of the Committee of the Whole (Item 1, Report No. 1, of the Committee of the Whole, which was adopted without amendment by Council on January 29, 2013) also provided a breakdown of the Phases 2-4 budget, including a \$20,000 contingency allowance.

The contract was awarded based on the successful bid in the amount of \$148,780 (less HST). A Change Order was subsequently processed to provide additional funds of \$18,219.56 (less HST) from the contingency allowance. Invoices processed to date, not including the 3% administrative fee, total \$164,879.91 (less HST), such that \$2,157.31 is remaining.

 - Review and incorporate comments provided in response to the draft EMG made available in June 2013; and
 - Update the EMG based on the relevant findings of the NHN Study.
- d) Provide an outline of the recommendations regarding (i) the Provincial review of the ORMCP and Greenbelt Plan; (ii) the GTA West Corridor EA, and (iii) a habitat compensation framework as a tool to implement the NHN Study findings.
 - Review the NHN scenarios, including the assessment of the potential impact of the GTA West Corridor, in relation to achieving select ecosystem targets.

Proposed Scope of Work

It is recommended that the contract with North-South Environmental Inc. be extended to support the completion of the Technical Report, following the June 17, 2014 Public Hearing, including the review of changes based on stakeholder input into the materials made available to the public. Specific tasks required to complete the Technical Report include:

- Changes to the GIS data comprising the NHN mapping based on recent approvals of development applications by the City;
- Changes to NHN mapping, revisions to Schedule 2 "Natural Heritage Network" of VOP 2010 and review of the proposed policy changes as a result of the review of the submissions and required stakeholder consultations following the meeting of the Committee of the Whole (Public Hearing) on June 17, 2014;

- Refinements to the NHN study resulting from the discussions with stakeholders.
- A thorough review of the history of modifications to Core Features and Enhancement Areas boundaries to ensure consistent application of decision rules;
- Responses to recommendations from the public for updated interactive maps of the NHN data; and
- Cataloguing GIS data to share with appropriate City partners to aid in projects related to infrastructure and/or conservation.

As a result, the additional funding request is based on the following main activities which will be supported by the consulting team:

- Edits and management of GIS data and VOP 2010 schedules;
- Consultation with stakeholders, evaluation of submissions;
- · Analysis and Reporting; and
- Following the completion of the Technical Report, efforts to refine the GIS data and/or VOP 2010 schedules and resolution of policies through the official plan approval process.

City staff have completed a review of recently approved development applications and required changes to the NHN mapping. City staff have also completed a preliminary review of all submissions in response to the materials made available for the June 17, 2014 Public Hearing. This allows for additional consultation to be scheduled over the next two months to finalize any amendments to Schedule 2 and policies of Chapter 3 of VOP 2010.

It is expected that the Technical Report will proceed to Committee of the Whole in early 2015. Subject to Council approval, the implementing amendment to the policies and schedules of VOP 2010 will go to Council for adoption; and then move to the York Region approval process. It will take approximately one year to complete these processes. It will be important to maintain the consulting services after the adoption of the Official Plan amendment in the event that post adoption modifications are required. Through this period, it will also be important to continually update the mapping data to maintain currency to the point of the final approval of the Official Plan amendment.

Implications for the Approved Budget

Funding for the Natural Heritage Network Study was included in the 2011 Capital Budget (PL-9025-11) in the amount of \$252,100 on the basis of a two part allocation. Phase 1 was treated as a stand-alone project and was funded in the amount of \$52,400. In the 2012 Capital budget, the funding for Phases 2, 3, and 4 was approved at \$199,700. The staff report to the January 29, 2013 meeting of the Committee of the Whole (Item 1, Report No. 1, of the Committee of the Whole, which was adopted without amendment by Council on January 29, 2013) also provided a breakdown of the Phases 2-4 budget, including a \$20,000 contingency allowance.

The contract was awarded based on the successful bid in the amount of \$148,780 (less HST). A Change Order was subsequently processed to provide additional funds of \$18,219.56 (less HST) from the contingency allowance. Invoices processed to date, not including the 3% administrative fee, total \$164,879.91 (less HST), such that \$2,157.31 is remaining.

The following is the budget breakdown for the NHN Study with the incorporation of the additional funds for the proposed Scope of Work.

Policies in the York Region Official Plan 2010 support the efforts of local municipalities to identify local greenlands systems.

Conclusion

The proposed addition to the Policy Planning Capital Budget for this Study is necessary to reflect the proposed Scope of Work, to be undertaken by the consultants, beyond the current contract, to support the finalization of the process through the approval of the resulting Official Plan amendment. The budget to complete the proposed Scope of Work is \$46,372.36, of which \$28,299.64 is provided from the balance remaining in the existing Capital Budget (PL-9025-11). It is recommended that the additional funding be sourced \$7,229.09 (40%) from the City-Wide Development Charges (CWDC) – Management Studies and \$10,843.63 (60%) from the 2014 Policy Planning Operating Budget – Professional Fees. The current budget for the NHN Study is \$252,100. The additional funding will bring the final budget to approximately \$270,200.

Should Council concur with the recommended budget amendment, this action would be considered as an amendment to the Capital Budget. Pursuant to the Municipal Act, before amending a budget, a municipality shall give notice of its intention to amend the budget at a Council meeting. Where a capital project has been subject to a public meeting during the adoption of the approved Capital Budget, and where additional funding is required to complete the approved works, inclusion of the matter on a Public Committee or Council agenda, in this case in the report identified as "Natural Heritage Network Study Inventory and Improvements Phases 2 to 4 – Amendment to the Vaughan Official Plan 2010, Budget Amendment", is deemed sufficient notice pursuant to Section 2(1)(c) by By-Law 394-2002.

On this basis it is recommended that the recommendations set out in this report be approved.
